II GENERAL

Art. 2 Serial Contests

2.1. HEPA Raplamaa people's Rally 2012. is a nation EAL Rally Championship 5th Stage in classes 4WD, 2WD S, 2WD V, SU, ML, female, J18.

III ROUTE DESCRIPTION

3.1. General Data

The total length of the route is ~ 130 km

Number of Special Stages (SS): 8

Additional tests, total length: ~ 20.00 mi

Number of Special Stages run twice: 4

Road surface: asphalt, gravel +

Course is divided into two leg and one of the ring.

Route description, schedule, and additional experiments are presented road book schemes.

3.2. Prohibited regions

Reconnaissance before the rally will not occur. Drivers, or their representatives are not allowed to stay in the rally roads selected for additional tests before 24.11.2012. 09:30.

3.3 Training

Training andtest drives for competitors, entrants and their representatives on the territories Juuru, Kehtna municipalities before the competition are allowed only in agreement with the Organiser of the rally.

IV CARS

Art. 4 Cars

- 4.1. Allowed to participate in the M1 and N1 category vehicles:
- 4.1.1. 2WD and 4WD cars, which has passed the technical inspection of the TÜV and note for that is contained in technical passport.
- 4.1.2. All of the components and equipment must be in working order.
- 4.1.3. To participate in EAL peoples rally championship point calculations, the vehicle must meet to EAL peoples rally technical terms.
- 4.1.4. ML CV calculation points for participation, the vehicle must meet the technical conditions of the ML.
- 4.1.5 sports cars (ASN technical card equiped cars) are prohibited participation in this rally.

4.2. Special conditions

- 4.2.1. It is required to have in the car first aid kit, tow rope, warning triangle, fire extinguisher presence and a blinking yellow or red light.
- 4.2.2. Radar (radar detector) Installation and use is prohibited.
- 4.2.3. Permitted tires
- 4.2.3.1. All tires must be vulcanized tread.
- 4.2.3.2. Use of slicks is prohibited. Also slicks are considered a tire with vulcanized tread grooves are less than 17 percent of the tread surface.

- 4.2.3.3. Tread pattern cutting is allowed only in specific competition tires.
- 4.2.3.4. Contest of the tread at any time must be at least 1.6 mm pattern 75 percent of the surface.
- 4.3. Classes of cars
- 4.3.1. 4WD (four-wheel street cars)
- 4.3.2. 2WD-V (two wheel drive street cars up to 1600 cm³)
- 4.3.3. 2WD-S (two wheel drive street cars more than 1600 cm³)
- 4.3.4. SU (Soviet Union produced RWD street cars)
- 4.3.5. Women (female contestants two wheel drive street cars)
- 4.3.6. J18 (up to 18-years old two wheel drive street cars)
- 5.3.7. ML (Moskvich league specified street cars)

V REGISTRATION FORM, REGISTRATION, SCRUTINEERING

Art. 5 Entry form, entry dates

- 5.1. Everybody with Northern European region countries national competitions driver license (including the so-called people's rally driver license) and an international driver's license contestants are allowed to participate with the permission of the contestants local ASN.
- 5.2. Entry form is submitted electronically.
- 5.2.1. Pre-registration is done online www.autosport.ee/rallyreg registration form.
- 5.2.2. Co-driver data may be presented and / or specify till the end of document control.
- 5.3. Competitors are required to arrive to the document check on Saturday 24 November 2012, from 06:45 to 09:30.
- 5.4. Contestants must submit to the document check following valid documents:
- A completed and signed entry form
- A document certifying the right to drive (not required for an under-18 driver, co-driver submissions adult classes)
- Car registration
- Car insurance policy or Green Card
- Driver License
- A proxy letter of car use (if necessary)
- 5.5. Contestants must submit in scrutineering a proper driving equipment.
- 5.6. Scrutineering
- 5.6.1. All cars taking part in the rally must attend Scrutineering on Saturday 24 November according to the following timetable:

Competition numbers 1-15 at 7:00 to 7:30

Numbers 16-30 contest at 7:30 to 8:00

Numbers 31-45 contest at 8:00 to 08:30

Numbers 46-60 contest at 8:30 to 9:00 Numbers 61-75 contest at 9:00 to 9:30

- 5.6.2. Race technical inspection of vehicles will take place at the RALLY HQ buildings workshop.
- 5.7. Contest entrants is up to 75 cars.
- 5.8. Registered participants will have an obligation to inform their non-participation.

VI ENTRY FEES, INSURANCE

Art. 6 Entry fees

- 6.1. Entry fees are as follows:
- 29.10.2012 to 21.11.2012 at 16.00 classes 4WD, 2WD S, 2 WD V, SU, ML, female, team of 100 EUR.
- 29.10.2012 to 21.11.2012 at 16.00 J18 class team of 50 EUR.
- 6.1.1. Latest date for receipt of entry forms is Friday, 21 november 2012th at 16.00.
- 6.1.2. The above charges are applicable only for the contestants, who agreed to carry advertisings.
- 6.1.3. A competitor may refuse from advertising before 21.11.2012. at 16.00, then they have to pay a double entry fee (payable in document control).
- 6.1.4. Cannot refuse from rally and competition numbers related ads.
- 6.1.5. Taxes (SR P 6.1.) must be paid in cash at mandate.
- 6.2. Entry form will only be accepted if the team entry fee is received in full amount to the organizer.
- 6.3. Insurance
- 6.3.1. Race car must have a valid insurance policy for a green card (Green Card).
- 6.3.2. Motor insurance policy is covering liabilities to third parties.
- 6.3.3. During the race Estonian Traffic Code is valid and must be followed.

VII ADVERTISING

- 7.1. All decals and advertising materials issued at the document check to the team must be in place before scrutineering of the cars and be placed in accordance with SR annex No. 2.
- 7.2. Ads arbitrary transformation (cut) is considered as infringement.

VIII GENERAL

- Art. 8 General duties.
- 8.1. Movement on and between special stages, following of a supplementary regulations

and following of a Road Book are being watched by the contest fact judges.

- 8.2. Infringements will be recorded on the time card, or transmitted to the clerk of the course by the fact judges.
- 8.2.1. Decision of the fact judges are final.
- 8.3. Race number and ID.
- 8.3.1. The organizer will provide each crew with race numbers.
- 8.4. In SS/Special Stages contestants must have the belts (safety belts) fastened and both crew members must wear a fastened helmet.
- 8.5. A contestant who has filled an entry form according to the requirements (SR p 6.1.1.) has no right to rotate a legal material requirement to the event organizer.

IX RALLY

- 9.1. Official time is the time in Estonia. Broadcasted each full hour Estonian Public Broadcasting.
- 9.2. First car starting time is 24 November 2012. a 10.00.
- 9.3. Change of Time Cards.
- 9.3.1. Competitors will be given a new Time Cards Controls: TC 0, TC 4A.
- 9.3.2. Leg I and Part II of the cars will start at two (2) minute start interval.
- 9.4. TC 8A for the final round can be arrived earlier without any penalties.
- 9.5. Retired crews must immediately inform the Rally HQ and to provide written notice to the organizer, (form at the end of the Road Book) marshals, ending car and to remove competition numbers/decals.
- 9.5.1. If during the race happened an accident, race car has to be present for inspectioning to the technical commission on race day.
- 9.6. Starting on a SS
- 9.6.1. Team is given timetable available pre-start minute.
- 30 seconds before the start turns on 1 blue light
- 15 sec 2 blue light turns on.
- 10 seconds before the start 3rd blue light turns on.
- 5 sec 1 red light

- 4 sec 2nd red light
- 3 sec 3rd red light
- 2 sec 4th red light
- 1 second before the start 5th red light
- start all lights switch off
- 9.6.2. False start, recorded by a beam 50 cm in front of the car.
- 9.7. Maintenance
- 9.7.1. Race car maintenance, refueling and changing tires is allowed as noted in Road Book. In Service Park can refuel a car only for the purpose intended place and in accordance with the marked areas.
- 9.8. During the Rally
- 9.8.1. Is one of regrouping:

I leg the end of Part I, - start-interval adjustment is done at the expence of dropedout and late arrivals.

New start time is entered on the time card.

- 9.9. In an accident in which a member of viewers is hurt, or has injuries must be reported according to FIA regulations annex IV, p. 33 (safety communications). In any case, have to be used legends OK / SOS signs.
- 9.10. In case of race car breakdown or accident, car should be immediately moved to a safe place to clear a race track. If the car is not moving, it must be installed a warning tirangle at least 50 m away from the direction of travel.
- 9.11. Movement of trail markers and touches in Special Stages are fixed by the fact judges.

X. SUMMARY OF PENALTIES

Oppositions XI

- 11.1. The opposing results/protests/appeals can be submitted in writing within 30 minutes after the announcement of preliminary results.
- 11.2. Opposing bail EUR 300.
- 11.3. All expenses and transportation of the car shall be borne:

- The plaintiff, if the sentence is not satisfied
- The defendant if the opposition was successful
- 11.4. The opposing on the race car technical parts can be done in writing up to 20 minutes after finishing of the last rallycar.
- 11.4.1. If it involves the opposition of various auto parts disassembly and reassembly of the opposing party to pay an additional security specified by:
- Opposition clearly defined part of the car (engine, steering, transmission, brakes, electrical installation, bodywork, etc.), 60 EUR
- Opposing the whole car 120 EUR
- 11.4.2. Objections to the cubic capacity of the engine can be exceptional on-site in the absence of the necessary measuring devices to solve within five working days after the event.
- 11.4.3. Justified in opposing the subsequent redistribution of awards.
